## PPA S.A.: Piraeus Port Authority S.A. at the 8th China International Import Expo (CIIE 2025)

**14 November 2025.** Piraeus Port Authority S.A. participated once again with a strong presence at the 8th China International Import Expo (CIIE 2025), held in Shanghai from 5 to 10 November 2025, highlighting the strategic importance of the Port of Piraeus in Greece-China cooperation, as well as its role as an international hub for trade, tourism and development in the broader Mediterranean region.

The CIIE is held annually by the Ministry of Commerce of China and brings together businesses from hundreds of countries, serving as a leading platform for international trade.

The senior management of PPA S.A., led by Chief Executive Officer Mr. Su Xudong and Deputy CEO Cpt. Jin Beiyuan, represented the company at the "Trade in Services" booth, where the multifaceted operations of the Port of Piraeus in commercial and shipping activities were showcased.
